## Board Updated on Risk Assessment, Warning Sirens

Director Pannell briefed FCEM&HS's Executive Committee May 16 about plans to update the county's Risk Assessment and perform a Capability Assessment/Gap Analysis for the county. Franklin County is ahead of the curve nationally; the Agency's work in this area is already consistent with new federal national preparedness planning guidance. Pannell also announced site selections are being reviewed for 10 new sirens to be installed in the coming months in Columbus as part of the county's Outdoor Warning Siren system. ## Franklinton Floodwall Tested June 9

In a major test requiring a temporary closure of part of SR 315, the City of Columbus Sewer Maintenance Operations Center successfully performed a practice closure on June 9 of the SR 315 roller gate, part of the 7-mile Franklinton Floodwall. Meanwhile, FCEM&HS will continue to recruit and train volunteers in sandbagging to help protect the city in the event of a catastrophic flood. ## EOC Functional Exercise set for Nov. 15

FCEM&HS and several emergency partners will hold a functional exercise Nov. 15 to test information sharing among multiple Emergency Operations Centers (EOCs). Participants include the Columbus fire and police divisions, Fairfield County EMA, state fusion center, FBI, Groveport and Pickerington police departments, Franklin and Fairfield County sheriff's offices, Deaf Services Center, and Columbus, Groveport and Pickerington local school districts. Objectives to be evaluated include intelligence/information sharing and dissemination, EOC management, and emergency public information and warnings capabilities.
